Mr. Syed Tasawur Kazmi (YP10-GB02) invite the attention of the Honorable Youth Minister for National Security towards the tragic incident happened in Quetta on Oct 23, 2014 in which 9 innocent Hazara fruit sellers were shot in a bus. Scores of innocent precious lives are lost as a result of sectarian violence in Balochistan. Series of shameful attacks have disturbed the lives of Hazara people very badly about 15 years. Immediate strict measures must be taken to stop the genocide of Shia Hazara people in Balochistan.

"Regarding PMDC's decision on allotting 50 percent seats in medical and dental colleges for females to flout merit and discrimination against women, this House suggests government takes surety from all medical college students to work for education, instead of adopting quota system".

"This House is of the view that Pakistan Railways should install GPS devices in their passenger trains and install screens, initially, just in five railway stations including Karachi, Quetta, Lahore, Rawalpindi and Peshawar. In addition to installation of screens, make available such timings displayed through mobile applications and on internet.

Also it shall result in manifold increase in the revenues of the Pakistan Railways."
